Title V of the Gramm-Leach-Bliley Act (GLBA)⁶ was enacted to ensure the privacy and security of personally identifiable information handled by financial institutions. Title V of the GLBA requires financial institutions to provide notice to customers of a possible disclosure of non-public personal information to non-affiliates and an opportunity to opt out of such disclosure. This non-public information includes an individuals address, as well as Social Security number, telephone number, and mothers maiden name. The prohibition against disclosure of this information without notice and the ability to opt out are subject to statutory exceptions provided in the GLBA. These exceptions allow for disclosure primarily for reasons of law enforcement, prosecution, or fraud prevention. The GLBAs privacy rule for re-disclosure binds recipients of non-public personal financial information. The GLBA requires financial institutions to adopt and implement appropriate safeguards for the personal information of their customers. 7 -----

---- The Health Information Portability and Accountability Act (HIPAA)⁸ was enacted partly to provide strong Federal protections for the privacy rights of patients. The HIPAA privacy rule prohibits health care providers from disclosing personal health information except when required or permitted under the rule. The HIPAA Privacy Rule permits health care providers to disclose personal health information for the purpose of carrying out essential health care functions such as patient treatment, payment for care, or health care operations that support treatment and payment.
